# **Notice of Annual General Meeting**

I am writing to inform you of the Annual General Meeting which is proposed be held on 20<sup>th</sup> November 2018 at 10 a.m. at The Magdalen Centre, Oxford Science Park, Robert Robinson Avenue, Oxford, OX4 4GA, at which Shareholder authority will be sought for a number of Resolutions.

This document also sets out the reasons for, and provides further information on the Resolutions, to explain why the Board considers the Resolutions to be in the best interests of the Company and its Shareholders as a whole and why the Directors unanimously recommend that you vote in favour of the Resolutions, as they have done at the Company's last Board meeting held on 10<sup>th</sup> October 2018.

#### Resolutions

All resolutions will be proposed as ordinary resolutions, other than resolution 5 which will be proposed as a special resolution. For an ordinary resolution to be passed, more than half of the votes cast must be in favour of the resolution. For a special resolution to be passed, at least three-quarters of the votes cast must be in favour of the resolution.

# **Resolution 1: Approval of the accounts**

The Company is required by law to put the Company's annual report and accounts for the year ended 30 June 2018 before the meeting. Shareholders are invited to vote to receive and adopt the Directors' and Auditors' Report and Accounts for the year ended 30 June 2018, a copy of which is being despatched to shareholders with this Notice of AGM.

# Resolution 2: Re-election of Dr Paul Harper as a director

Under the Company's articles of association, at least one third of directors are required to retire and stand for re-election at every Annual General Meeting, Dr Paul Harper has accordingly retired at this year's Annual General Meeting and is standing for re-election.

## Resolution 3: Appointment and remuneration of auditor

### Notes

### APPOINTMENT OF A PROXY

- 1. As a member of the Company you are entitled to appoint a proxy or proxies to exercise all or any of your rights to attend, speak and vote at a general meeting of the Company. You can only appoint a proxy using the procedures set out in these notes.
- 2. You may appoint more than one proxy provided each proxy is appointed to exercise rights attached to different shares. You may not appoint more than one proxy to exercise rights attached to any one share. You must indicated for each proxy holder, the number of shares in relation to which they are authorised to act as your proxy.
- 3. Appointment of a proxy does not preclude you from attending the meeting and voting in person. If you have appointed a proxy and attend the meeting in person, your proxy appointment will automatically be terminated.
